# **EMPLOYEE MATTERS AGREEMENT**

This EMPLOYEE MATTERS AGREEMENT (this "<u>Agreement</u>") is dated as of October 1, 2020, between SASOL CHEMICALS (USA) LLC, a Delaware limited liability company ("<u>Sasol Chemical</u>"), Louisiana Integrated PolyEthylene JV LLC, a Delaware limited liability company (the "<u>Company</u>") and LyondellBasell LC Offtake LLC, a Delaware limited liability company ("<u>Purchaser</u>").

WHEREAS, Sasol Chemical and the Company have entered into a Business Separation Agreement, dated of even date herewith (the "<u>Separation Agreement</u>"), as such agreement may be amended from time to time, pursuant to which Sasol Chemical and the Company have agreed for Sasol Chemical to transfer or cause to be transferred certain assets of the Transferred Business (as defined in the Separation Agreement) to the Company, and for the Company to assume or cause to be assumed certain liabilities of the Transferred Business, in accordance with and subject to the terms of the Separation Agreement;

WHEREAS, Sasol Chemical, the Company, Purchaser and, for certain provisions therein, Lyondell Chemical Company, a Delaware corporation, and Sasol Limited, a corporation organized and existing under the laws of the Republic of South Africa, have entered into that certain Membership Interest Purchase Agreement, dated of even date herewith (the "<u>Purchase Agreement</u>"), as such agreement may be amended from time to time, pursuant to which Sasol Chemical and Purchaser have agreed for Sasol Chemical to sell 50% of the outstanding equity interests of the Company to Purchaser, in accordance with and subject to the terms of the Purchase Agreement;

WHEREAS, following the closing of the transactions contemplated by the Purchase Agreement (the "<u>Closing</u>"), the equity interests of the Company will be owned 50% by Sasol Chemical and 50% by Purchaser;

WHEREAS, certain employees of Sasol Chemical and its Affiliates will receive offers of employment to become employees of Purchaser or an Affiliate pursuant to this Agreement; and

WHEREAS, the parties hereto desire to set forth their agreement as to certain matters regarding the transfer and treatment of employees in connection with the transactions contemplated by the Separation Agreement and the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereby agree as follows:

# ARTICLE I

# Identification of Business Employees

SECTION 1.01. <u>Dedicated Employees</u>. Schedule 1.01 to this Agreement sets forth a true and complete list of the names of each of the employees of Sasol Chemical and its Affiliates (excluding the Company, the "<u>Sasol Group</u>") who are dedicated to the operation of the Transferred Business (such employees, together with (a) any employees who are hired in the

ordinary course of business to replace any such employee whose employment terminates prior to the Closing and (b) any employees who are hired in the ordinary course of business to fill any position that is identified on Schedule 1.01 as being vacant as of the date hereof, in each case, so long as any such hiring is made in consultation with Purchaser, the "Dedicated Employees"). With respect to each Dedicated Employee, Sasol Chemical has made available to Purchaser true and correct Employee Information with respect to each such Dedicated Employee. As used herein, "Employee Information" means: (i) job title, (ii) work location, (iii) annual salary or wage rate, (iv) target bonus for the current performance period, (v) target value of long-term incentive compensation, (vi) aggregate value of long-term incentive awards currently outstanding, (vii) active or inactive status, (viii) visa status (if applicable), (ix) accrued unused vacation, (x) exempt or non-exempt status under the Fair Labor Standards Act (the "FLSA"), (xi) date of birth, and (xii) date of hire and service date (if different). Sasol Chemical acknowledges and represents and warrants that the Company does not employ, and has never employed, any individuals prior to the Closing, and is not liable for any pre-Closing employment-related liabilities.

# SECTION 1.02. Additional Business Employees.

Schedule 1.02 to this Agreement sets forth a list of the names of additional (a) employees (other than the Dedicated Employees) (the "Available Employees") that Sasol Chemical has determined may be required by the Company and Purchaser or its Affiliates to operate the Transferred Business on a basis that is separate from the Sasol Group, which Available Employees will be made available by Sasol Chemical to be hired by Purchaser or its Affiliate. With respect to each Available Employee, Sasol Chemical has made available to Purchaser true and correct Employee Information. Sasol Chemical will reasonably cooperate with Purchaser and its Affiliates to provide Purchaser and its Affiliates with access to the Available Employees, at reasonable times during working hours and on reasonable notice, for the purpose of evaluating Purchaser's or its Affiliates' need for and discussing potential employment terms with the Available Employees. Not less than 20 days prior to the Closing Date, Purchaser or its Affiliate will identify to Sasol Chemical which of the Available Employees it wishes to offer employment at the Closing (the "Selected Employees" and, together with the Dedicated Employees, the "Business Employees"). Following the date of this Agreement and, as applicable, following the date of Purchaser's or its Affiliate's initial identification of the Selected Employees, the list of Available Employees and Selected Employees may be updated by mutual agreement of the parties from time to time.

(b) For the avoidance of doubt, neither Purchaser nor any of its Affiliates shall be required to make offers of employment to all or any of the Available Employees. However, with respect to any Available Employee that does not receive an offer of employment from Purchaser or its Affiliate (a "<u>Rejected Employee</u>"), Purchaser or its Affiliate shall, if Sasol Chemical determines that it no longer has a role for such Rejected Employee in its organization and terminates the employment of such Rejected Employee within 45 days following the Closing Date (each a "<u>Terminated Employee</u>"), reimburse Sasol Chemical for 50% of the severance costs incurred by Sasol Chemical pursuant to the Sasol (USA) Corporation Severance Policy dated April 1, 2015 in connection with the termination of employment of such Terminated Employee. All Liabilities arising out of or relating to any claim by a Rejected Employee that Purchaser's determination to not offer employment to such Rejected Employee was for a discriminatory reason or otherwise not made in accordance with any applicable Law shall be split equally between Purchaser and Sasol Chemical.

#### ARTICLE II

#### Transfer of Employees

#### SECTION 2.01. Offers of Employment.

Except as provided in SECTION 2.02, not less than 20 days prior to the (a) Closing Date, Purchaser or its Affiliate shall make a bona fide written offer of employment to each Business Employee who is then employed with the Sasol Group on such reasonable terms and conditions (including with respect to compensation and benefits) as are determined by Purchaser or its Affiliate in its sole discretion (a "Qualifying Offer"), provided, however, that, the terms of such Qualifying Offers and Purchaser's or its Affiliate's actions with respect thereto must satisfy all applicable Laws. Notwithstanding anything herein to the contrary, Purchaser's or its Affiliate's Qualifying Offer with respect to any particular Business Employee shall be (i) contingent on the occurrence of the Closing, (ii) effective as of such Business Employee's Transfer Time (as defined below), (iii) conditioned upon such individual satisfying Purchaser's or its Affiliate's reasonable pre-employment screening requirements (e.g., background checks, drug testing, etc.) and (iv) conditioned upon the transfer of any visa or work authorization under applicable Law (as applicable). Any Business Employee whose Qualifying Offer is conditioned upon the transfer of a visa or work authorization that has not been obtained or approved by an applicable governmental authority as of the Closing (a "Visa Transfer Employee") will remain an employee of the Sasol Group until such time as the transfer of such visa or work authorization has been obtained or approved, and the Sasol Group shall second such Visa Transfer Employee to Purchaser (or its applicable Affiliate), with Purchaser or its applicable Affiliate reimbursing Sasol Chemical for 50% of the actual employment costs of each Visa Transfer Employee (excluding costs associated with any defined benefit pension plans, equity or equity-based compensation, and post-retirement medical, life insurance, or other welfare-type benefits) during the period beginning on the Closing Date and ending immediately prior to such Visa Transfer Employee's Transfer Time (the "Secondment Period"); provided, however, that (A) the amount Purchaser or its Affiliate shall be required to reimburse shall not exceed 50% of an amount equal to the sum of each Visa Transfer Employee's current base salary plus 34% of such base salary; and (B) during each Visa Transfer Employee's Secondment Period, no employment costs associated with such Visa Transfer Employee shall be charged to Sasol Chemical or any of its Affiliates pursuant to the Operating Services Agreement. Each Qualifying Offer shall provide at least five (5) days for the Business Employee to accept the Qualifying Offer and Purchaser or its Affiliate will promptly notify Sasol Chemical of any Business Employees who do not accept Purchaser's or its Affiliate's Qualifying Offers. Except as provided in SECTION 2.02, each Business Employee who accepts a Qualifying Offer shall commence employment with Purchaser or its Affiliates as of 12:01 am United States Central Time on the Closing Date (the "Transfer Time") and upon the commencement of such employment, shall be considered a "Transferred Employee" hereunder; provided, that, with respect to any Visa Transfer Employee, (X) such Visa Transfer Employee shall become a Transferred Employee hereunder only at the time such Visa Transfer Employee actually commences employment with Purchaser or its Affiliate (following the date the transfer of such Visa Transfer Employee's visa or work authorization is approved by the applicable governmental authority) and

(Y) the "Transfer Time" shall mean the date of such Visa Transfer Employee's actual commencement of employment with Purchaser or its Affiliate. Sasol Chemical will terminate or cause to be terminated the employment of each Transferred Employee, effective as of immediately prior to the Transfer Time.

(b) Effective as of the Transfer Time, Purchaser or its Affiliates shall be solely and completely responsible for paying and providing all wages, salaries, employee benefits and other compensation to all Transferred Employees, and to each of them, for any and all personal and other services such employees provide to, or for the benefit of, the Company and Purchaser or its Affiliates, from and after the Transfer Time. In the event a Business Employee rejects a Qualifying Offer from Purchaser or its Affiliates, Purchaser and its Affiliates, including the Company, shall have no further obligation or liability in relation to such Business Employee.

SECTION 2.02. Certain Disabled Employees; Leaves of Absence. Except as required by applicable Law, each Business Employee who is on a short or long-term disability, workers' compensation or other approved leave of absence as of the date of this Agreement or who goes on such a leave of absence prior to the Closing and, in either case, remains on a leave of absence as of the Closing Date, shall receive a Qualifying Offer from Purchaser or its Affiliates when he or she presents himself or herself as ready and able to commence active employment with the Company or Purchaser or its Affiliates, but only if such Business Employee presents himself or herself for active employment no later than the later of (i) six (6) months following the Closing Date or (ii) such longer period as may apply under any applicable Law. Sasol Chemical and its Affiliates shall promptly notify Purchaser and its Affiliates of any such Business Employee who is able to commence active employment with Purchaser or one of its Affiliates within the time limit prescribed in this SECTION 2.02. With respect to any Business Employee covered by this SECTION 2.02, such Business Employee shall become a Transferred Employee only at the time such Business Employee actually commences employment with Purchaser or its Affiliates and the "Transfer Time" shall mean the date of such Business Employee's actual commencement of employment with Purchaser and its Affiliates.

# ARTICLE III

#### Retained Benefit Plans and Employee Liabilities

SECTION 3.01. <u>Retained Benefit Plans and Employee Liabilities</u>. Except as expressly set forth in this Agreement, the Purchase Agreement or the Separation Agreement, or as required by Law, none of the Company, Purchaser or any of their respective Affiliates, shall assume sponsorship of, or any assets or Liabilities relating to or at any time arising under, pursuant to or with respect to, any Benefit Plan or any other benefit or compensation plan, program, policy, or contract of any kind at any time that is sponsored, maintained or contributed to by Sasol Chemical or its Affiliates, or under or with respect to which Sasol Chemical or its Affiliates has any Liability ("<u>Sasol Benefit Plans</u>"). As of the Transfer Time, except as required by applicable Law or the terms of any Sasol Benefit Plan, the Transferred Employees shall cease to participate as active employees in and shall cease to accrue additional benefits (other than earnings on benefits accrued at or prior to the Transfer Time, to the extent applicable) under any Sasol Benefit Plan. Effective immediately prior to each Transferred Employee's Transfer Time, Sasol Chemical and its Affiliates shall waive and release all confidentiality, non-competition, non-solicitation, non-

disclosure and similar agreements, if any, between Sasol Chemical or its Affiliates and such Transferred Employee to the extent they would restrict or encumber such Transferred Employee's ability to perform his or her duties as an employee of Purchaser or its Affiliates. Except as expressly set forth in this Agreement, Sasol Chemical shall retain all Liabilities with respect to (a) the Transferred Employees relating to their employment or service with Sasol Chemical or its Affiliates prior to the Transfer Time and the termination of their employment or service with Sasol Chemical or its Affiliates at the Transfer Time and (b) the Business Employees who do not become Transferred Employees. Sasol Chemical or its Affiliates shall take all necessary actions to (i) on or before each Transferred Employee's Transfer Time, fully vest as of such date such Transferred Employee's account balances and other accrued benefits under all Sasol Benefit Plans that are "employee pension benefit plans" within the meaning of Section 3(3) of ERISA, and (ii) with respect to each Transferred Employee's target short-term bonus compensation for the performance period that commenced on July 1, 2020, provide for such Transferred Employee to remain eligible to receive a pro-rated award (based on the number of days in such performance period elapsed as of such Transferred Employee's Transfer Time), which pro-rated award will be paid following the completion of the performance period at the same time and at the same payout level, if any, as short-term bonus awards are paid to Sasol Chemical's other employees who participate in the same short-term bonus compensation programs. Each Transferred Employee who participates in Sasol Chemical's and its Affiliates' long-term incentive compensation arrangements (the "LTI Plans") will, with respect to his or her outstanding awards under the LTI Plans (the "LTI Awards"), be entitled to receive payments as a "good leaver" thereunder, in accordance with the terms of the LTI Plans and LTI Awards as in effect on the date of this Agreement. The parties acknowledge and agree that any Losses related to Sasol Chemical's and its Affiliates' legal obligations and requirements set forth in this SECTION 3.01 shall be deemed to be Retained Liabilities for purposes of the Separation Agreement and subject to the indemnification provisions in Section 3.2 of the Separation Agreement.

SECTION 3.02. <u>WARN Act.</u> As of the Closing Date and for a period of ninety (90) days thereafter, the parties will provide each other with such information regarding each employee who has suffered or will suffer an Employment Loss (as defined below) at any site of employment where a Business Employee is located, in each case, as is reasonably necessary to comply with their respective obligations under the WARN Act. As used herein, "<u>Employment Loss</u>" means an "employment loss" within the meaning of the WARN Act that occurs either within the ninety (90) days immediately preceding and including the Closing Date or during the ninety (90) days immediately following the Closing Date.

#### ARTICLE IV

#### Post-Closing Compensation and Benefits

SECTION 4.01. <u>Post-Closing Compensation and Benefits</u>. Except as otherwise set forth in this Agreement, Purchaser or its Affiliates shall determine the terms and conditions of employment (including compensation and benefits) for the Transferred Employees for any periods following the Transfer Time. For the avoidance of doubt, none of Purchaser or any of its Affiliates shall be obligated to continue the employment or service of any particular Transferred Employee, or any particular term or condition of employment or service, for any particular period of time following the Closing Date. The parties to this Agreement acknowledge that, unless required by applicable Law, none of the Company, Purchaser or any of their respective Affiliates shall be required to provide (i) defined benefit pension plans, (ii) equity or equity-based compensation, or (iii) post-retirement medical or life insurance, or any welfare-type benefits to any Transferred Employees, or any other Person.

SECTION 4.02. <u>Service Credit</u>. Purchaser, its Affiliate, or the Company, as applicable, shall, give each Transferred Employee full credit for service to Sasol Chemical and its Affiliates for purposes of determining eligibility to participate in, level of benefits or rate of accrual under, or vesting of benefits under, any employee benefit plan of Purchaser or its Affiliates in which Transferred Employees participate after the Closing ("<u>Purchaser Benefit Plans</u>") to the same extent and for the same purposes as recognized under the comparable Sasol Benefit Plan, except for purposes of level of benefits or rate of accrual under any defined benefit pension plans or post-retirement medical, life insurance or other welfare benefit plans or arrangements or for any purpose under any nonqualified deferred compensation, bonus, incentive, retention, equity or equity-based compensation plans or arrangements or to the extent doing so would result in a duplication of benefits.

SECTION 4.03. <u>Health and Welfare Benefits</u>. As of the date on which the Transfer Time occurs, the Transferred Employees shall be eligible to enroll in the Purchaser Benefit Plans providing group medical, prescription drug, dental, vision, term life insurance, short term disability, long term disability and flexible spending arrangements under a cafeteria plan intended to be qualified under Section 125 of the Code, to the extent such plans are maintained by Purchaser or one of its Affiliates, in accordance with, and subject to the terms and conditions of, such plans. The Sasol Group shall be solely responsible for all Liabilities with respect to continuation coverage under Section 4980B of the Code for current or former employees of Sasol Chemical and its Affiliates (including the Company), and any spouse or dependent thereof, or any other Person who is or becomes a "M&A Qualified Beneficiary" as defined in Treasury Regulation Section 54.4980B-9 as a result of the consummation of the transactions contemplated by this Agreement, the Separation Agreement or the Purchase Agreement, in each case, with respect to any "qualifying event" that occurs upon or prior to the Transfer Time.

SECTION 4.04. <u>Deductibles; Waiting Periods; Pre-Existing Conditions</u>. Purchaser shall, or shall cause one of its Affiliates to, use commercially reasonable efforts to cause each Purchaser Benefit Plan that is a group health benefit plan to (i) in the plan year in which the Closing Date occurs, give each Transferred Employee credit for any amounts paid toward deductibles and out-of-pocket maximums paid during the same plan year with respect to any corresponding Sasol Benefit plan in which the Transferred Employee participated prior to the Transfer Time to the extent such amounts were satisfied or did not apply under the corresponding Sasol Benefit Plan, and (ii) waive any waiting period and pre-existing condition limitation for any Transferred Employee (and any eligible, covered spouse or dependent thereof) in the plan year in which the Transferred Employee (or such spouse or dependent) ceases to participate in the comparable Sasol Benefit Plan. Sasol Chemical will reasonably cooperate with the Company to provide Purchaser or one of its Affiliates with the information necessary to implement this provision.

SECTION 4.05. Effective as of the Closing Date, the <u>401(k) Plans</u>. Transferred Employees who were eligible to participate in the Sasol Benefit Plan that is a defined contribution plan and includes a cash or deferred arrangement within the meaning of Section 401(k) of the Code (the "Sasol 401(k) Plan") shall begin to participate, if eligible, in the defined contribution retirement plan(s) intended to be tax qualified that are sponsored by Purchaser or one of its Affiliates (the "Purchaser 401(k) Plan"). The Purchaser 401(k) Plan shall not assume any Liabilities of the Sasol Group, but may accept "eligible rollover distributions" (as defined in Section 402(c)(4) of the Code) from the Sasol 401(k) Plan to the extent any Transferred Employees are eligible to receive such a distribution from such plan that they in turn elect to rollover to the Purchaser 401(k) Plan. Prior to the Closing, Sasol Chemical or one of its Affiliates shall take all actions as may be necessary to permit the continuation of loan repayments after each Transferred Employee's Transfer Time if such Transferred Employee has an outstanding loan from the Sasol 401(k) Plan. Such loan repayments shall be made directly by the Transferred Employee to the Sasol 401(k) Plan.

SECTION 4.06. <u>Paid Time Off.</u> Upon each Transferred Employee's Transfer Time, Sasol Chemical or its Affiliate shall pay to such Transferred Employee all of such Transferred Employee's accrued and unused vacation, sick leave and paid time off days as of such Transferred Employee's Transfer Time, in each case, that have been accrued in accordance with the Sasol Group's vacation, sick leave and paid time off policies.

# ARTICLE V

#### Cooperation

SECTION 5.01. <u>Cooperation</u>. Following the date of this Agreement, each party shall, and shall cause their respective agents and vendors to, use reasonable best efforts to cooperate with respect to any employee compensation, benefits or human resources systems matters and Benefit Plan documents, employee data and other information that any party reasonably determines require the cooperation of any other party in order to accomplish the objectives of this Agreement. The parties shall comply with all obligations to inform or consult with employees, employee representatives and any Governmental Authorities regarding the transfer of the Transferred Business and Transferred Employees to the Company and Purchaser or its Affiliates. Sasol Chemical and its Affiliates shall assist Purchaser and its Affiliates, as applicable, in facilitating communications with the Business Employees regarding potential employment with Purchaser or its Affiliate. Sasol Chemical and its Affiliates shall not take any action, or fail to take any action, that could reasonably have the effect of discouraging any Business Employee from accepting a Qualifying Offer.

# ARTICLE VI

# Non-Solicitation of Employees

SECTION 6.01. <u>Non-Solicitation</u>. Except with respect to the Dedicated Employees and Available Employees, for a period of 6 months following the Closing Date, Purchaser and its Affiliates shall not solicit, canvass, approach, encourage, entice or induce any employee or other service provider of Sasol Chemical or any of its Affiliates to terminate his, her or its employment or engagement with Sasol Chemical or any of its Affiliates. For period 6 months following the Closing Date, Sasol Chemical and its Affiliates shall not solicit canvass, approach, encourage, entice or induce any employee or other service provider of the Company or of Purchaser or its Affiliates to terminate his, her or its employment or engagement with the Company or with Purchaser or its Affiliates. Nothing herein shall prohibit any party from making any general job advertisements or solicitations that are not targeted at employees who are not permitted to be solicited hereunder.

#### ARTICLE VII

#### Miscellaneous

SECTION 7.01. <u>Entire Agreement; Incorporation of Terms</u>. This Agreement, together with the Separation Agreement, Purchase Agreement and other Ancillary Agreements, constitutes the entire agreement among the parties with respect to the matters covered hereby and supersedes all prior agreements and understandings among the parties with respect to the matters covered hereby. The provisions of Sections 6.4, 6.5 and 6.7 through 6.18 of the Separation Agreement are incorporated herein by reference.

SECTION 7.02. <u>Other Terms</u>. Any capitalized terms used herein but not defined herein shall have the meanings specified in the Separation Agreement or the Purchase Agreement, as applicable.

SECTION 7.03. <u>No Closing; Conflicts</u>. The obligations of the parties hereunder are wholly contingent on the Closing of the transactions contemplated by the Purchase Agreement, and this Agreement will automatically terminate without further action by any party hereto at any time before the Closing upon the termination of the Purchase Agreement in accordance with Article X thereof. If this Agreement terminates in accordance with this SECTION 2.02, no party hereto shall have any Liability of any kind to any other party hereto or any other Person on account of this Agreement, except as may be provided in the Purchase Agreement. The terms and conditions of the Purchase Agreement or the Separation Agreement, on the one hand, and the terms and conditions of the Purchase Agreement or the Separation Agreement, on the one hand. SECTION 7.04. <u>No Third Party Beneficiaries</u>. Nothing in this Agreement will confer upon any Person (nor any beneficiary thereof), other than the parties to this Agreement, any rights or remedies whatsoever, including any third party beneficiary rights, by reason of this Agreement or under or with respect to any employment arrangement or any compensation or benefit plan, program, agreement or arrangement described in or contemplated by this Agreement and each person (and any beneficiary thereof) will be entitled to look only to the express terms of any such plan, program, agreement or arrangement for his, her or its rights thereunder. The purpose of this Agreement is to specify the respective potential responsibilities and obligations of Sasol Chemical, the Company and Purchaser (and their respective Affiliates) as between each other, but it does not affect, impair, enhance, modify, construe or interpret the rights of any employee of Sasol Chemical, the Company, Purchaser (or any of their Affiliates) or any dependent or beneficiary thereof under or in respect of any such plan, program, agreement or arrangement. Nothing in this Agreement: (i) will amend, establish, or terminate or will be construed to amend, establish, terminate or interpret the terms of, any plan, program, agreement or arrangement described in or contemplated by this Agreement; or (ii) shall prohibit Purchaser or any of its Affiliates (including after the Closing, the Company) from (a) terminating the employment or service of any Person at any time for any or no reason or (b) establishing, amending or terminating any Benefit Plan, Purchaser Benefit Plan or any other benefit or compensation plan, policy, program, agreement or arrangement maintained by any of them.
