REQUEST FOR EXPRESSION OF INTEREST





1. BACKGROUND

Sasol Petroleum Mozambique Limitada (SPM) (hereinafter referred to as Sasol) is the Operator of the Production Sharing Agreement (PSA), which is a license holding in the Province of Inhambane, Mozambique, containing light oil and gas resources. Sasol has been actively executing the PSA Plan of Development which was approved by the Government of Mozambique in 2016 and a revision thereto approved in September 2020. The revised Plan of Development describes Sasol's ongoing intent to optimally develop the light oil and gas resources contained in the Inhassoro, Temane and Pande fields.

A key objective of the revised Plan of Development is to enable the supply of natural gas to the Central Térmica de Temane power plant, which is also under development as part of Mozambique's national electrification programme (the Temane Regional Electricity Project). Another key objective is to enable the production of liquefied petroleum gas (LPG) for domestic consumption. This requires the construction of a new light oil, gas and LPG processing facility and associated surface facility infrastructure (hereinafter referred to as the PSA Project) in the Temane area in the Province of Inhambane.

In support of the engineering, procurement and construction of the PSA Project, amongst others, Sasol will be required to appoint construction contractors to execute the various scopes of construction works.

2. CONSTRUCTION REQUIREMENTS

The PSA project requires construction works commonly required for large oil, gas and petrochemical projects. Interested contractors will need to prove their appropriate ability and experience to successfully execute construction works as listed below in compliance with the technical requirements and criteria applicable to oil, gas and petrochemical projects in Mozambique whilst satisfying Mozambican local content requirements.

The required construction works are categorised as per the following:

REFERENCE CONSTRUCTION WORKS CATEGORIES

- **E1 Temporary Facilities:** Provision and erection of construction offices, project store, medical station, mess facilities, mini substation, electrical power reticulation, access control system, public address system, etc particularly for the construction site.
- **E2 Temporary Facilities Services:** Provision of services including cleaning, catering, & maintenance particularly for the construction site.
- **E3 Site Prep Contract:** Site clearance, construction of access roads, earthworks, construction of stormwater drainage ditches and channels, fencing and civil works for temporary facilities.
- **E4 Logistics Contract:** Provision of logistic services for the transportation of materials and equipment from point of dispatch to the site or any other required location including logistics surveys to routes to site and abnormal loads.
- **E5 Civil Works Contract:** Construction of reinforced foundations for structures, pipe racks and equipment, trenching for underground services, supply and installation of concrete and PVC sewer systems, construction of concrete slabs and paving, final finishing works including block retaining walls, final grading and surfacing of site roads,
- **E6 Building Contract:** Construction of the Control Room Administration Building and Gate House including foundations, structural concrete elements, brickwork, roofing, finishes and building fixtures and provision and installation of plumbing, drainage, electrical systems, fire and gas system and HVAC.
- E7 Structural, Mechanical, Electrical, Instrumentation and Piping Contract: Detailed design, fabrication and erection of structures and pipe racks including fireproofing. Fabrication and installation of piping including painting and insulation. Installation of mechanical equipment including vessels, pumps, heat exchangers, fired heaters, process refrigeration package, flare, water treatment packages, etc. Installation of cable racks and cables, installation of control panels within substation and equipment room, cable pulling and laying and cable termination of power cables and control cables. Connection of field equipment and installation of field electrical infrastructure. Installation of below and above ground earthing. Installation of DCS/ESD system and network cabinets, field instrumentation and instrument cabling and tubing.
- **E8 Heavy Lift Contract:** Engineering and production of detailed lifting studies for all lifting operations. Provision of all cranes, transport equipment, ancillary equipment (slings, shackles, spreader beams, mats, etc.), labour and management. Crane requirements are mobile hydraulic crane of 500t capacity with support of smaller telescopic mobile cranes of 50t to 400t capacity with valid certification.

Interested Contractors are to note that the PSA Project comprises an Inside Battery Limits (IBL) and Outside Battery Limits (OBL) scope and, although, this Request for EOI seeks interest in respect of scopes under the IBL scope, Sasol may be required to look into optimisation opportunities to combine certain scopes and/or contract in a way that allows for synergies between the two scopes, whilst still maintaining its commitment to Local Content.

3. OBJECTIVE OF THIS EOI

This request is intended to solicit information required to enable Sasol to identify and assess suitably qualified and experienced Contractors registered or established and operating in the Republic of Mozambique, in order to create an opportunity for such Contractors to potentially participate in the future bidding for this project.

Sasol hereby invites eligible Contractors to indicate their interest to bid for specific Construction Works identified from the above list. Interested Contractors should provide appropriate information showing that they have the required qualification(s), ability and relevant experience to perform the identified Work.

Kindly refrain from submitting any irrelevant information and documentation. Kindly ensure that each item hereunder is addressed and that your submission is structured strictly in accordance with the list of required documentation and information hereunder:

- Jasol has been over the years a driver of socio-economic development through its investments and operations. A key aspect of this development impact has been enabled through its commitment to Local Content. Sasol is fully committed to improved levels of local content and supports the local content requirements for the procurement of goods and services which are designed to promote the development of Mozambican owned businesses and know-how. The aim is to maximise procurement from Mozambique owned (majority and minority) and Inhambane Head Quartered companies. Accordingly, Sasol encourages interested contractors to maximize any potential local participation when responding to this Request for EOI. Relative to Local Content, contractors are to:
 - **a.** Provide detail of the Contractor's ownership structure [percentage shareholding held by shareholders as well as a description of the identity of shareholders] and details of registration of the company in terms of Mozambican legislation.
 - **b.** Indicate what percentage of Mozambican labour, staff and management the Contractor envisages using to execute the Works.
 - **c.** Indicate what percentage of the Contractor's estimated cost would be based on Mozambican procured materials and services.
- 3) Provide relevant financial information for last 3 years, current year and a forecast for next year. [Turnover, net profit and total equity reserves].
- 4) Technical capability
- **a.** Provide a detailed track record of work performed over the past 5 years specifically for the referenced category.
- **b.** Provide details of work performed for Sasol in Mozambique over the last 5.
- **c.** Provide full details of the following: Contractor's technical skills; equipment quality and capacity; resources' skills, qualifications, experience and capacity; planning systems / progress measuring system; and workshop capacity to proof that it can successfully execute the Work applicable to the referenced category.
- Provide Information and detail of the Contractor's accredited quality, health, safety and environmental management systems as well as all applicable accreditations.
- 6) Provide detail of the Contractor's knowledge and experience of the NEC.
- 7) Ability to conduct business in the English Language.

Potential bidders will be selected in terms of Sasol's evaluation criteria [as determined by Sasol], taking into account the details that the Contractor supplies, all other information [including all risks associated with this project]. Potential bidders will be selected by Sasol in its sole and unfettered discretion.

Contractors who satisfy the pre-qualification criteria will be required to sign a confidentiality agreement with Sasol, prior to receiving any further information regarding the project and for the purpose of further commercial process.
