## CHECKERS XTRA SAVINGS & SASOL REWARDS E-MAIL ACQUISITION COMPETITION TERMS & CONDITIONS

- 1. The joint promotional competition is run by Shoprite Checkers (Pty) Ltd ("Checkers") and Sasol Oil (Pty) Ltd ("Sasol").
- For purposes of this Term and Conditions, and issue and redemption of Sasol Rewards Points, Sasol Oil (Pty) Ltd shall be referred to as "the Promoter" and Shoprite Checkers (Pty) Ltd as "Checkers."
- 3.
