



## TERMS AND CONDITIONS FOR THE SASOL MZANSI TOUR COMPETITION

Please read the Promotional Competition Terms and Conditions (“the Terms and Conditions”) carefully. Your participation and entry will constitute your agreement to comply with these Terms and Conditions.

### Competition

This Promotional Competition (“the Competition”) is organized by Sasol Oil (Pty) Ltd, Registration Number 1981/007622/07, its associated group of companies, their designated agencies or promoters and companies in association with the Competition (“the Promoters”).

#### 1. Who may enter?

- 1.1 The Competition is open to citizens of South Africa who hold a South African barcoded green ID Book or ID smartcard or valid South African passport and Non-South African Citizens with a valid Passport and Certificate of Residence **and** is a Sasol Rewards Member.
- 1.2 All persons entering this Competition (“the Participants”) agree that the Terms and Conditions, rules and provisions as set out herein are binding on them.
- 1.3 By entering this Competition, all Participants acknowledge that they have the legal capacity to enter the Competition and hereby agree to be bound by the Terms and Conditions as set out herein, which Terms and Conditions will be as interpreted by the Promoters.
- 1.4 The Promoters’ decision regarding any dispute will be final and binding and no correspondence will be entered thereafter.
- 1.5 Every Participant must be a natural person of 18 (eighteen) years or older at date of his/her entry into the Competition.
- 1.6 The Participant **must** be a Sasol Rewards Member, and if not, may register on <https://www.sasolrewards.co.za/> to become a Sasol Rewards Member and then shall be eligible to enter the Competition.

#### 2. Who may not enter?

- 2.1 Participation in this Competition specifically excludes any employee, director, member, partner, agent or consultant or any person who directly or indirectly controls or is controlled by the Promoters and/or immediate family members of any employee, director, member, partner, agent or consultant of or person indirectly or directly in control or controlled by the Promoters, their advertising agencies, advisers and dealers (“Disqualified Persons”).
- 2.2 Participants may not enter this Competition or be declared a winner if they have won a competition promoted by the Promoters within the preceding 12 (twelve) months of the Competition commencement date.
- 2.3 Companies cannot participate in this Competition.

#### 3. Competition period

- 3.1 The Competition commences on 8 December 2023 and runs until 23:59:59 18 January 2024, both days inclusive (“the Competition Period”).
- 3.2 The Competition Period may be extended or curtailed at the discretion of the Promoter.

#### 4. Prizes and Entry Mechanics

- 4.1 There are Instant Prizes Grand Prize of 5x R50 000.00 Sasol Fuel Vouchers to be loaded as Sasol Rewards Points and to be redeemed at Participating Sasol Fuel Stations.



## 4.2 Instant Prizes

- 4.2.1 Eligible participants qualify for Instant Prizes if they meet the minimum Fuel spend criteria in each transaction, are Sasol Rewards Members and complete their entry.
- 4.2.2 A Participant with a valid entry is eligible to win Instant Prizes varying from – Data Bundles (varying values across all networks) R200 Pamper vouchers, 20% Off Gym Memberships, R200 Movie and Music streaming vouchers, 1 year online Gaming Membership; and/or Fast-Food vouchers (“Instant Prizes”).
- 4.2.3 To be eligible to win an Instant Prize, the participant must purchase Fuel to the minimum value of R600 per individual transaction at any Participating Sasol Convenience Centre, swipe your Sasol Rewards Card, scan the QR code on the cash slip and follow the steps as directed on the register their entry on the microsite link.
- 4.2.4 Participants are asked if they are a Sasol Rewards Member, if answered Yes, participant will be informed that they will be contacted within 24hrs with a validation result.
- 4.2.5 If answered No, participant will be provided with the link <https://www.sasolrewards.co.za> to sign up for Sasol rewards which will allow the participant to participate in the promotional competition and eligible to win Instant Prizes.
- 4.2.6 alternatively visit any participating Sasol Filling Stations and ask for a Rewards Card.
- 4.2.7 Upon successful Validation, the participant will be sent an SMS asking them to click the URL Link [www.sasolmzansitour.co.za](http://www.sasolmzansitour.co.za) which takes them to the “Spin and Win”
- 4.2.8 The participant is then eligible to Spin the Wheel and win Instant Prizes with each valid purchase.
- 4.2.9 Rewards Vouchers in respect of the Instant Prize will be sms'd to the Winner.
- 4.2.10 The participant is eligible to win more than one Instant Prize with each valid entry.
- 4.2.11 This must be done for each individual transaction being entered.
- 4.2.12 Fuel must be purchased, and entries received between the dates and times as set out in 3.1 above.

## 4.3 Grand Prize of 5 x R50 000 Sasol Fuel Vouchers issued in Sasol Rewards Points

- 4.3.1 To enter to win 1 of 5 R50 000 Sasol Fuel Vouchers, purchase Fuel at any Participating Sasol Convenience Centre to the minimum value of R600 (six hundred rand) per individual transaction, swipe your Sasol Rewards Card, take a clear picture of your cash clip with your cellphone camera and Whatsapp such picture to 0860 335 444 together with your name and surname.
- 4.3.2 A Winner of one Grand Prize shall not be eligible to win another Grand Prize.
- 4.3.3 The Grand Prize draw takes place once a week over a period of 5 weeks, draw dates as follows –
  - Draw 1 – 18 December 2023;
  - Draw 2 – 27 December 2023;
  - Draw 3 – 3 January 2024;
  - Draw 4 – 10 January 2024; and

- 4.3.4 All eligible entries received prior to such draw dates shall be eligible to win a Grand Prize.

- 4.3.6 The winner will be confirmed only once all entry verifications have been conducted by the Promoter and receipt of any information as required by the Promoter.
- 4.3.7 A winner will be contacted within [days] of the Grand Prize draw, which contact shall only be on the cellphone number from which such entry was submitted. No other contact numbers shall be used or accepted by the Promoter.
- 4.3.8 The Grand Prize is not transferable and will only be issued in the Winner's name and Fuel Voucher Rewards Points loaded on the Winner's Sasol Rewards Account.



- 4.3.9 Failing verification shall disqualify the Winner and a new Winner shall be drawn by the Promoter.
- 4.3.10 Multiple entries with the same cash slip will result in disqualification of such participant.
- 4.3.11 The more you fill for a minimum value of R600 the more entries you may submit for the Grand Prize.
- 4.3.12 The Winner may redeem such Sasol Rewards Points won at any Participating Sasol Convenience Centre.

#### 4.4 General Terms

- 4.4.1 "Fuel" means Petrol (ULP 93 and ULP 95) and/or Diesel.
- 4.4.2 "Prize" means the prize as set out in points 4.1, 4.2 and 4.3 above, subject to the relevant terms and conditions.
- 4.4.3 The Purchase applies to Fuel at any Participating Sasol Convenience Centre.
- 4.4.4 Note: Not all Sasol Convenience Centers are participating in this Promotional Competition. The participating Sasol Convenience Centers are listed at <https://www.sasolrewards.co.za/sitelist>.
- 4.4.5 Entry to this Competition does not make a Participant a winner.
- 4.4.6 If the Participant has won and contact required by the Promoter, no other mobile number will be used to contact the Participant other than the mobile number as recorded on the Participant's Sasol Rewards Member profile. No other mobile number will be accepted by the Promoters or used by the Promoters to contact the Participant.
- 4.4.7 Multiple entries are permitted provided that each entry is in accordance with the entry requirements as outlined. Multiple entries of the same purchase will result in disqualification.
- 4.4.8 The Promoter accepts no responsibility for entries lost, misdirected, illegible, late, or altered. Entries that do not comply with these Terms and Conditions will be disqualified.
- 4.4.9 It is the Participant's responsibility to ensure that any information which you provide to the Promoter is accurate and complete.
- 4.4.10 Any and all tax implications and liabilities as a result of winning a Prize will be solely borne by the winner.

- 4.4.22 Once the Prize has been handed over to the winner in terms hereof, the results of the Competition are final in all respects and no correspondence will be allowed.

- 5.1 The Prize winners will be contacted on the cellphone number as stored and recorded in their Sasol Rewards profile and same shall apply to redeem the Prize and any further or other contact. It is therefore the Sasol Reward's member's obligation to ensure that his/her details on his/her profile are correct as at time of entry.
- 5.2 The Promoters will randomly select a winner for the Grand Prize from all the entries received and shall follow the mechanics as set out above.
