

**Terms & Conditions: Stand a chance to WIN 1 of 30 Weber 47 cm Charcoal Compact Kettle Grill**

1. This Promotional Competition ("Competition") is organised by Coca-Cola Africa (Proprietary) Limited, Sasol Oil (Pty) Ltd and PESSO Marketing CC ("Promoter").
2. The Competition is open to permanent residents and citizens of South Africa over the age of 18 (eighteen) years, in possession of a valid form of identification (South African Identity Document or Passport) **except** any minor, employee, director, member, partner, agent or consultant of the Promoter, or any person who directly or indirectly controls or is controlled by the Promoter and/or immediate family members of any of the above persons, its advertising agencies, advisers, dealers, suppliers and Bottlers of beverages identified by the trademarks owned by or licensed to The Coca-Cola Company, its affiliates and/or associated companies.

By entering the Competition, all participants and the winner agree to be bound by these terms and conditions/rules as interpreted by the Promoter, whose decision regarding any dispute will be final and binding. The Promoter reserves the right at any time, without notice, to amend, modify, or change these terms and conditions/rules and any prizes, and to postpone, suspend or cancel this Competition and any prizes, or any aspect thereof, without notice at any time, for any reason which the Promoter reasonably deems necessary.
4. **The Competition is only valid within South Africa.** Participants must be within South Africa at the time of entering the Competition, for the verification process and at the time of the prizes being awarded should they be declared a winner, failing which such person will be disqualified and the draw of a replacement entry shall take place under the same terms and conditions as the first draw.
5. The Competition will commence on 9 September 2021 and will end at 23h59 (South African time) on 20 October 2021 ("the Duration"). The winners will be announced on 3 November 2021.
6. The Participants stand a chance to win 1 of 30 Weber 47 cm Compact Charcoal Kettle Grill-worth R2 500,00 each ("Prize"). There will be a total of 30 winners.
7. Participants will be required to do the following:
  - a. Buy any 2 x 1.5L products owned by The Coca-Cola Company (all variants) at participating Sasol Delight stores; and
  - b. SMS the word "COCA-COLA" + Your Name + Unique Till Slip No. to **40644**.

Each SMS will be charged at R1. Free and Bundled SMS's do not apply. Please keep receipt for proof of purchase.
8. An independent auditor will conduct an audited random draw to select a total of 30 winners on 25 October 2021 that will be awarded the Prize and to verify the winners. The Promoter's decision is final and no correspondence will be entered into.
9. All winners will be notified telephonically and by SMS on the number that the participant used to enter into the Competition with a subsequent follow up to confirm their details by 27<sup>th</sup> October 2021.
10. In order for the particular entries to be confirmed as valid, the possible winners will be required to provide their proof of identification including their full name, contact number and e-mail address, to deliver the Prize.
11. Participants may enter the Competition subject to the following:
  - a. No automated entries will be allowed and all entries must be made by a natural person manually using the SMS entry line/number to 40644.
