

Sasol (Valpre and Stimorol) Fitbit Competition Rules

1. The promoter of the competition is CCBSA and Mondelez, in association with Sasol Oil (Pty) Ltd .
2. The name of the competition is Sasol (Valpre Stimorol) Fitbit campaign.
3. The competition will run from 24 January 2019 to 6 March 2019.
4. By entering the competition and/or accepting any prize (if you are a winner), you agree to be bound by these terms and conditions.
